

14 Reasons to Vote ... AGAINST... Bill Baillargeon Allegan County Circuit Court - November 4, 2008

1. William Baillargeon was a "youth facilitator" for Affirmations Community Center¹, a gay-lesbian organization.²
2. Was on the Board of Advisors³ of the Triangle Foundation a gay- lesbian-bisexual-transsexual rights⁴ and pro-abortion⁵ organization, which is now pressuring Wayland Public Schools⁶ to teach acceptance of homosexuality.⁷ (Though he tries to downplay this connection⁸ additional documentation betrays his agenda and values.)
3. Supported same-sex marriage in Michigan by giving \$500 to Coalition For A Fair Michigan⁹, an activist same-sex-marriage group, during the 2004 Michigan ballot question campaign on same-sex marriage.¹⁰
4. Contributed \$6500 to pro-abortion and pro-gay-rights Jennifer Granholm for Governor.¹¹
5. Received his public position as magistrate through appointment by Governor Granholm.¹²
6. Received his public position as Allegan County Judge through appointment by Governor Granholm¹³, yet he campaigns to "retain the incumbent".¹⁴
7. Gave to Stonewall Democrats of Saugatuck Douglas¹⁵, a gay-rights activist group.¹⁶
8. Gave \$1 000 to Obama for President and \$250 to Richardson for President¹⁷, both of whom are pro-abortion^{18 19} and pro-gay-rights.^{20 21}
9. Contributed to Justice Caucus²² who opposes conservative Judge Cliff Taylor and supports pro-abortion and pro-gay-rights Sen. Carl Levin.²³
10. Supported by the local incumbent judges²⁴ who have repeatedly given the bid for court appointed attorney services to the higher bidder costing the county hundreds of thousands of dollars.²⁵
11. A Detroit native, recently moved to Saugatuck, never elected to office, his experience in law is in workman's compensation.²⁶
12. His website and public comments present him as a good Catholic²⁷ yet he opposes Catholic teaching by supporting pro-homosexual and pro-abortion organizations and candidates.
13. Never married, no children. (Note: The majority of cases in circuit court are family related cases.)
14. He is endorsed by gay-lesbian-rights organization, "Between the Lines".²⁸
